## Comment on the Draft Housing Element

There are two weeks left to review and comment on the Draft Housing Element. Submit your comments by August 5!



The Housing Element is one of the required elements of the General Plan update, and provides a road map to address and plan for housing in our community. All jurisdictions in the Bay Area, including Tiburon, must update their Housing Element for the 2023-2031 planning period.

Over the past year, the community and stakeholders have participated in an extensive outreach and engagement effort for completion of the Housing Element update. The draft element was released for public review earlier this month, beginning a 30-day public comment period.

We invite you to review the draft Housing Element and provide feedback before the end of the public review period on **Friday, August 5, 2022**. On **Wednesday, August 3, 2022**, the Town Council will hold a public meeting to discuss the draft Housing Element and the comments received. As part of the discussion with the Town Council, the Council may consider additional revisions to the draft Housing Element prior to submitting the document to the California Department of Housing and Community Development (HCD) for their required review.

After HCD reviews the draft Housing Element, and provides any feedback or comments, a revised draft will be available to the community. The Housing Element will then be

scheduled for additional public hearings with the Planning Commission and the Town Council for review and adoption. The adoption of the Housing Element is expected to be completed as part of the General Plan Update in January 2023.
