# A WORD FROM THE TOWN MANAGER



## The Vexing Problem of Peninsula Traffic

I'd like to thank our intrepid residents who came to the traffic forum last Thursday evening, September 20, at the Reed School campus. We appreciate their willingness to help address this challenge that affects the quality of life for virtually everyone on

the peninsula.

The meeting offered a presentation from "CART" - Community Action to Reduce Traffic (so dubbed largely to have a pronounceable acronym!). CART is comprised of elected officials from Tiburon and Belvedere, the town and city managers and police chiefs, Reed and St. Hilary school representatives including the PTA, transportation specialists and more. They have been coming together twice monthly for some time now to better understand the traffic problem on the boulevard and to devise ways to tackle it. The purpose of the forum last Thursday was for CART to share information it has developed to date, and to create an opportunity for members of the public to tell CART about their experiences, observations and ideas.

The <u>CART presentation</u> illustrated the challenging nature of the problem. Simply put, traffic on the boulevard exceeds capacity when school is in session and commuters, contractors and parents driving kids are all on the road simultaneously, especially in the morning between 7:45 and 8:30. Mid to late afternoons present another traffic "peak" as the situation reverses itself. Interestingly, there is substantial traffic in both directions during heavy congestion times - unlike, say, the Golden Gate Bridge where there is a very heavy and predictable flow in only one direction during peak hours. The presentation provided baseline information on many congestion-related elements including vehicle counts, the significant jump in school enrollment (7% just this past year, and 37% over the past eight) current modes of travel to school (walk, bike, bus, etc.) and much more.

Voter Registration
Closes on
October 22nd



Monday, October 22 is the last day to register to vote for the November 6 election.

If you have not yet received your sample ballot and notification of your polling place, your registration may not be current. If you have moved since the last election, or if you have changed your name or mailing address, you need to contact the Marin County Registrar of Voters to update your voter registration

There are several ways to do this: contact the Registrar at 473-6456, obtain a registration form

Many traffic-reducing ideas were floated at the forum. They included the installation of traffic circles, particularly one at Trestle Glen, better synchronization and calibration of traffic signals (they are currently set to maximum green time on the boulevard), a tram running along the multi-use path, more school buses and more emphasis on kids getting to school on foot or bike (the schools are already work hard at this, and bike ridership is up). Another suggestion was the construction of pedestrian and bicycle underpasses (or flyovers) at Tiburon Boulevard intersections to improve traffic flow by eliminating these traffic-stopping crossings; safer crossing under or over the boulevard might also encourage more parents to let their kids get to school on bike or foot using the multi-use path. Avenida Miraflores and Trestle Glen were both identified as possible candidates for this approach.

So what's next? CART has a lot of information and many ideas to sort, analyze and prioritize. Many of the concepts (like more transit of any variety, underpasses or physical changes to the Boulevard, etc.) need to be evaluated carefully for their feasibility and cost, and will require more public discussion, including on how they might be funded. Any physical changes within the Caltrans right-of-way, which includes all of Tiburon Boulevard, will require Caltrans approval.

My expectation is that CART will undertake this next step over the ensuing months and return to a public forum early in the New Year with more information and firm recommendations for consideration. From the CART effort to date it is painfully clear that there is no silver bullet to banish the traffic problem. But, there is hope that some of the ideas that have emerged, especially if adopted in combination, could make a meaningful dent. Despite the magnitude of the challenge, CART remains committed to making recommendations for action. What the community decides after that will emerge from the public process yet to come.

# Richardson Bay Sanctuary Waters Closed to Boat Traffic Starting October 1



## **Fall Bird Migration Underway**

Annual closure from October 1 through March 31 protects important migrating bird species that use the Bay for overwintering.

Staff at the Richardson Bay Audubon Center & Sanctuary remind the community that Sanctuary waters are closed to all boat traffic and in-water activities (including

**kayaks & paddleboards)** from October 1, 2012 through March 31, 2013. The closure protects tens of thousands of migratory ducks, geese, and shorebirds that use the Bay for refueling on their southward travels, or while they overwinter right here in on Richardson Bay.

"We are grateful for the community support and understanding regarding the importance of protecting this habitat," said Kerry Wilcox, the Center's Sanctuary Manager. "As the summer winds down and migratory birds start to make their way into the Bay Area, we want to spread the word that the closure is just around the corner. With the herring spawn successes of the last couple years, the number of birds in the Sanctuary is expected to be high, and it is especially important to avoid disturbing them while they feed and rest." Over-winter health can be an especially important factor in determining reproductive success for these birds during the following summer.

The annual closure is mandated by an ordinance of the Richardson Bay Regional Agency. Approximately 900 acres of Bay waters are covered by the ordinance, extending south from the edge of the Cove housing complex to the tip of Strawberry Point, east to Belvedere and north to Blackie's Pasture. Audubon manages this area as a wildlife sanctuary, focused on the waterbirds using the Bay. The Sanctuary boundaries are designated by buoys and permanent, marked pilings.

## **About the Sanctuary**

Richardson Bay Audubon Center and Sanctuary provides sanctuary habitat for migratory waterbirds and other wildlife. It also involves the community through education, conservation and restoration programs. Click <a href="here">here</a> for more information.



Bring the family and enjoy a beautiful Fall day at Blackie's Pasture. Parking is limited so walking and carpools are encouraged.


