## More on the Light Brown Apple Moth

The proposed aerial spraying of the light brown apple moth (often referred to as the LBAM) has been on a lot of minds lately. If you have been following this in the papers, you know that this little pest is native to Australia and is undiscriminating in its choice of vegetative foods: more that

2,000 plant species are known to be susceptible to it including ornamentals, food crops and California native plants.

To combat the LBAM, the California Department of Food and Agriculture (CDFA) has proposed a variety of methods, but the one that has many people concerned is the proposed aerial application of a pheromone compound. While technically classified as a pesticide because it has the potential to collapse a population of pests, pheromones do not kill the moths but instead disturb their mating process by mimicking the scent by which male months find females. Concern appears to be centered not so much on the pheromone itself, but the other inert ingredients that might be included in the spray or its delivery mechanism.

At the core of the LBAM controversy is the vast quantity of often contradictory information on whether the proposed aerial spraying poses a health or environmental hazard. The CDFA says it is safe; others dispute this assertion. While this sorts out, the Tiburon Town Council has joined the growing list of Marin and Bay Area communities calling for a moratorium on spraying unless and until the spraying is determined to be both safe and necessary. Marin Assembly member Jared Huffman is also involved in this process. His bill, AB 2765, would require publication of all ingredients in any spray, at least one public hearing to consider alternatives and certification of safety prior to spraying. This type of intervention to ensure safety is most viable at the state level, since spraying will ultimately be a state decision. Marin Supervisor Charles McGlashan is also tracking this issue closely on behalf of the county.

On May 7, the Tiburon Town Council will hear a presentation from the Marin County Sustainability Director and others about a major renewable energy initiative under consideration by the County and all the incorporated cities within it. The proposal is called Marin Clean Energy (MCE). The very short story: it would create, under a provision in state law designed for this purpose, a local consortium for the purchase of renewable sources of electricity which, in turn, would be distributed through the existing PG&E network. The concept is to push Marin into a substantially higher renewable or 'green' energy profile than it would otherwise assume over the coming decades.

The Tiburon Town Council will need to decide later this year, probably in the fall, if the Town should join this effort. The May 7th presentation is designed to provide everyone with a greater understanding of the benefits and potential risks of the program for the community.

## Green Building: A Timely Topic



Green Building is a very popular concept right now, as concerns over global climate change, greenhouse gas emissions, carbon footprints, melting glaciers and ice caps are frequently heard in the news. More



and more local communities are adopting green building programs, and the Town of Tiburon is no

exception.

Earlier this year, the Town appointed a subcommittee of Town Council and Planning Commission members to provide policy direction to Town Staff in developing an appropriate green building program for Tiburon. While the program is still under development, the primary elements are likely to consist of the following:

#### Residential Construction

Green building standards for residential construction would be based on the Build-it Green green points rating system. This rating system has been adopted by the cities of Novato, San Rafael, and Larkspur in Marin County, and by numerous other local governments throughout the Bay Area. It establishes a standardized rating system for calculating how "green" a project is. Communities establish the total points required to be met by project type. New single family homes and total remodels would need to achieve higher green point totals than small additions. The Build-it Green point system is popular because it allows great flexibility for homeowners and builders in the construction materials and methods used to achieve the necessary green points.

### Non-Residential Construction

Green building standards for commercial and other non-residential construction would be based on the Leadership in Energy and Environmental Design (LEED $^{(8)}$ ) Green Building Rating Systems, which provide different levels of green achievement such as certified, silver, gold and platinum. LEED certification is a more involved and demanding process, so larger commercial and other non-residential buildings would have higher standards of green achievement than smaller buildings.

## **Construction & Demolition Materials Recycling**

The Town will likely upgrade its construction and demolition recycling requirements, which were established several years ago. This program ensures that when buildings are demolished, those materials that can be recycled are recycled rather than buried in a landfill.

### Town of Tiburon Projects

The Town Council feels very strongly that the Town should take a leadership role and set examples by "greening" its own civic projects. Solar panels installed on the Town Hall roof a few years ago are one example. A new Public Works Corporation Yard, still in

the early planning stages, offers another opportunity for the Town to lead by example and be a model of green building technology.

## Energy Efficiency in Larger Homes

The Town Council recently adopted enhanced energy efficiency standards in large homes. Any home larger than 3,500 square feet (no matter how large) must now use no more energy than a 3,500 square foot home. This requirement follows identical measures adopted by the County of Marin and the cities of San Rafael and Mill Valley.

## Marin Climate & Energy Partnership (MCEP)

Tiburon is an active member of this joint effort of Marin municipalities and the County of Marin to establish and implement local climate action plans and goals. The mission of MCEP is to reduce greenhouse gas emissions, promote long-term climate protection through the planning process, encourage "climate-friendly" goods and services, establishing Marin as a center for greenhouse gas-reducing technologies, and developing innovating financing strategies to promote greenhouse gas reduction strategies and technologies. Each party to this effort is analyzing its own community operations and characteristics to focus on the most effective and appropriate measures that can be taken locally to reduce greenhouse gas emissions.

In the long run, efforts by local government are only a small part of the larger picture of reducing greenhouse gas emissions and slowing global climate change. Every individual can make a difference by contributing to the effort. Fortunately, there is a tremendous amount of information available to the general public, in literature and on the internet, which can help us all be a little "greener".

## Town Receives Grant Funding to Improve Steps, Lanes & Paths



Thanks to the efforts of Town Engineer Nick Nguyen and Associate Planner Scott Phillips (shown at left), the County of Marin has awarded the Town \$350,000 in federal grant money from the non-motorized transportation pilot program (NMTPP) to improve steps, lanes and paths.

Marin County is only one of four

communities nationwide that was selected for this pilot program, the purpose of which is to increase the use of bicycling and walking for everyday transportation and decrease motor vehicle usage. The other communities are Columbia, Missouri, Minneapolis-St. Paul, Minnesota, and Sheboygan County, Wisconsin.

Staff has targeted several well-used Tiburon paths for this project: a) Raccoon Lane between Centro West and Mar West, b) Cayford Drive, and c) the steps and path connecting Jefferson Drive to Reed Ranch Road. The improvements are scheduled to be completed by September 2009.


