NOTICE IS HEREBY GIVEN that the Design Review Board of the Town of Tiburon will hold a public meeting to consider, among others, the request of:

619 Ridge Road; Assessor's Parcel No. 059-013-07; File Nos. DR2023-056, and VAR2024-013; Consideration of Site Plan and Architectural Review for the construction of an approximately 4,122 square foot two-story single-family dwelling with an approximately 662 square foot attached garage with various landscape improvements and an in-ground swimming pool with a Variance request for a proposed lot coverage of 16.4% (approximately 3,469 square feet) where 15% (3,244 square feet) is the maximum coverage permitted on properties of this lot size (21,625 square feet) located in the RO-2 zone. This project is categorically exempt pursuant to CEQA guidelines section 15303: New Construction or Conversion of Small Structures.

The approximately 764 square foot attached Accessory Dwelling Unit (ADU) that is proposed complies with all developed standards established under the ADU Ordinance (Tiburon Municipal Code Section 16-52.100) is not subject to Site Plan and Architectural Review.
