The meeting will be held in person and will also be televised live on Zoom. Members of the public have the option of participating in-person or remotely via Zoom by following the instructions on the meeting agenda.

NOTICE IS HEREBY GIVEN that the Planning Commission of the Town of Tiburon will hold a public meeting to hold an annual update review of approved Conditional Use Permit (File No. CUP2024-005) for the Tiburon Fire District's annual "Chipper Day" events:

Blackie's Pasture Overflow Parking Area; Assessor's Parcel No. 055-041-01 (P & R Parks and Recreational Zone); File No. CUP2024-005; Annual review of a Conditional Use Permit to operate and manage five annual "Chipper Days" on the second Saturday during the months of May, June, July, August and September. The events are permitted to take place during the hours of 9am to 4pm and provide an opportunity for residents to bring their cut vegetation to Blackie's Pasture for free removal. The program helps the community and the Tiburon Fire District to comply with Defensible Space requirements as instructed by the California Fire Code and Ordinance #129. Note: In conducting this public hearing, the Planning Commission has the authority to add or modify conditions of approval, or revoke the permit if deemed warranted, or determine if further study and/or analysis is required.

This project has been determined to be categorically exempt from the California Environmental Quality Act (CEQA) under Section 21080(b)(4) of the Public Resources Code, which excludes specific actions taken to prevent or mitigate an emergency; and under Guidelines Section 15301: Existing Facilities.
