Old Rail Trail Maintenance Begins July 21 Other Construction Projects May Impact Traffic

We all love the Old Rail Trail (ORT). Leading from Blackie's Pasture to the intersection of Tiburon Boulevard and Mar West, this very popular, paved, multi-use pathway is used by thousands of visitors each year. Whether walking, running or biking, users of the ORT are treated to spectacular views and access to beautiful open space areas like Blackie's Pasture, McKegney Green and South Knoll. Many segments of the paved trail were constructed decades ago, and like any paved surface, require periodic maintenance and rehabilitation to keep it safe for all users.

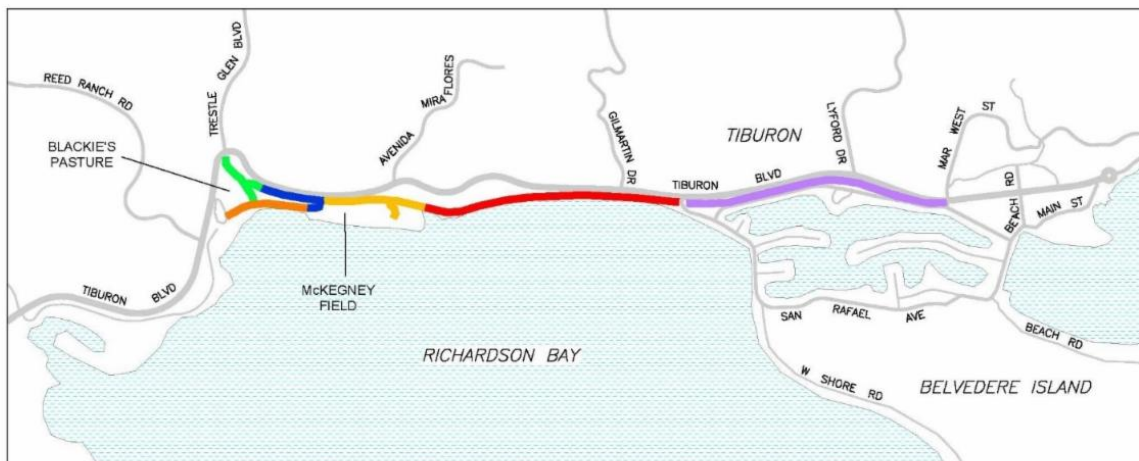
Over the past year, staff has been working with our design consultant to plan a repair project to address a number of issues along the ORT. The project was put out to bid in early 2020, and on June 3, the Town Council awarded a contract to complete the work and authorized the project to move forward.

Construction on the Old Rail Trail Rehabilitation Project is scheduled to begin on July 21, 2020 and is expected to continue through August 2020. The project will rehabilitate the asphalt paving and the decomposed granite edge paths for the entire length of the Old Rail Trail.

While the Town and the contractor are committed to minimizing disruption to trail users, trail closures and detours will be necessary to complete the work. The Town appreciates everyone's patience and understanding during construction.

The following measures are being implemented to minimize impact to trail users:

- Construction is divided into six separate segments, as shown on the map below, and contractor work is limited to one segment at a time, unless approved by the Town in advance.

TRAIL SEGMENTS

- Whenever possible, trail closures will be placed such that sufficient space is provided for pedestrians to access adjacent, open trail segment(s) or other pedestrian paths.
- Trail closure signs will be posted 3 days prior to the closure of each trail segment.
- Trail closure dates will be limited to 3 consecutive working days.
- There will be no trail closures allowed on weekends or holidays.
- Trail closures will be between 8AM and 5PM.

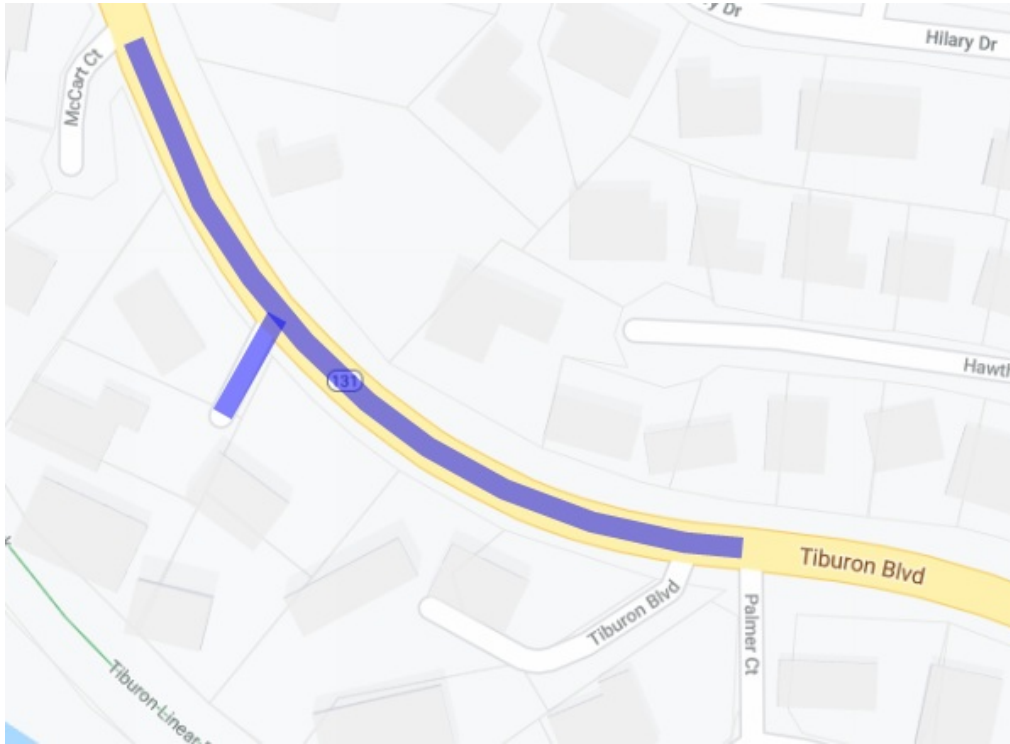

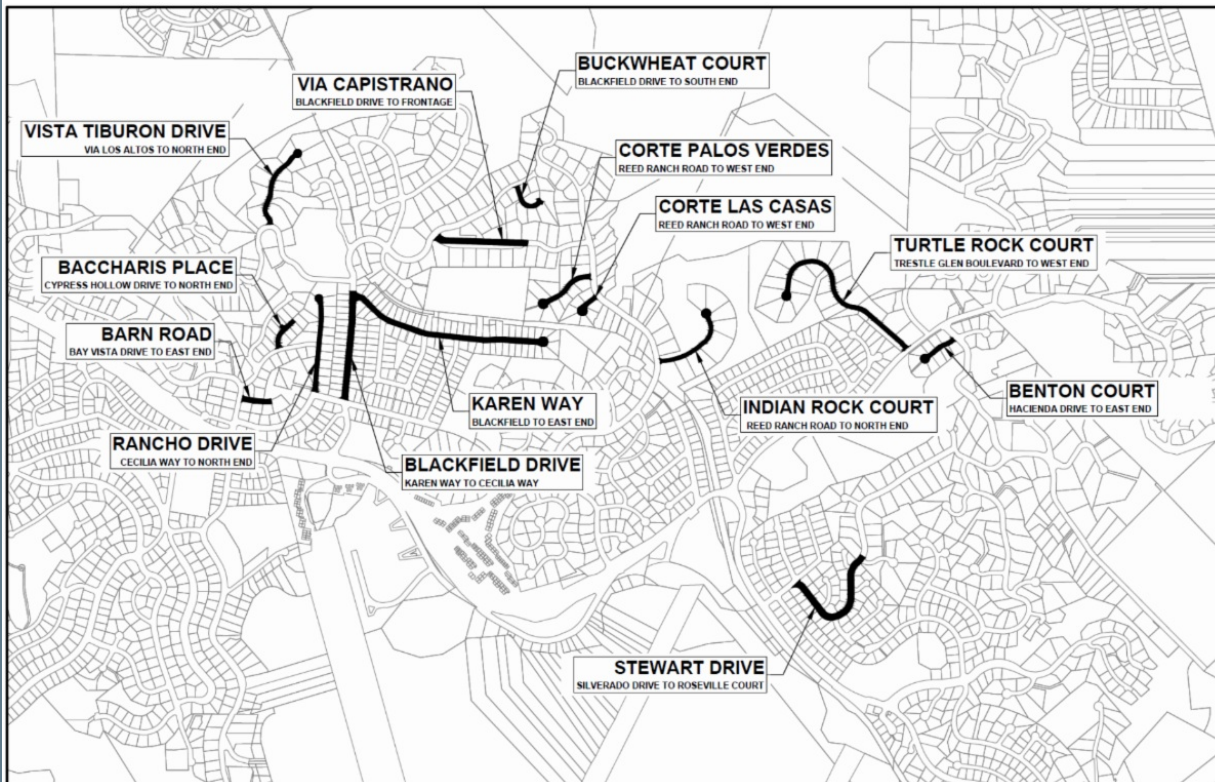
Upcoming Construction Projects May Impact Traffic

Beginning Sunday (7/19) evening, PG&E will begin work to upgrade the gas main and services on Tiburon Boulevard, McCart Court and Palmer Court. Work hours are

scheduled for Sunday - Thursday nights from 9 p.m. - 6 p.m. For more information, please email GasProjectInfo@pge.com. The work is expected to take place between July 19 - September 5, 2020.



Construction on the 2020 Pavement Rehabilitation Project is planned to begin on July 20, 2020 and continue through September 2020. Work planned during July is limited to concrete repairs and upgrading curb ramps to meet current Americans with Disability Act accessibility standards. COVID-19 Update: Additional Industry Sectors Close in Marin

This week, Governor Newsom announced additional industry closures in all 58 California counties due to the recent spike in COVID-19 cases across the state. The Governor has

ordered indoor dining, wineries and breweries, museums and zoos, and family entertainment centers (movie theaters, bowling alleys, etc.) to close immediately. Bars and pubs were required to cease both indoor and outdoor operations.

Marin County is one of 30 counties in California on the State's "watch list" of California counties experiencing concerning increases in COVID-19 numbers. Marin County was added to the State's watch list in early July - forcing the immediate closure of indoor dining at that time.

In addition to the state-wide closure orders, Governor Newsom also ordered all 30 counties on the State's "watch list", including Marin County, to immediately cease the following operations:

- Fitness centers
- Indoor worship
- Non-essential office space
- Personal care services (hair salons and barber shops)
- Indoor malls
