

## TOWN OF TIBURON NOTICE OF PUBLIC HEARING

Teleconference Special Meeting

Notice is hereby given that the Tiburon Planning Commission will hold a public hearing to consider marking a recommendation to the Town Council regarding an application (PZ2021-001), filed by the Jacqueline Bos and Eric McCrath Revocable Living Trust, to prezone four unincorporated parcels of land totally approximately 10.45 acres located at and in vicinity of 4916 Ranch Road within the Tiburon Planning Area and Town of Tiburon Sphere of Influence to RO-2 (residential open) zoning district, in anticipation for the annexation of the properties by the Marin Local Agency Formation Commission (LAFCo) into the Town of Tiburon. The project site consists of Marin County Assessor Parcel No. 038-053-17, 038-061-14, 038-061-30 and 038-061-27.

The public hearing will be held as a teleconference on Wednesday, September 8, 2021. The meeting will begin at 6:30 P.M.

Consistent with Executive Orders No. N-25-20 and N-29-20 from the Executive Department of the State of California, the Town Council meeting will not be physically open to the public and all council members will be teleconferencing into the meeting. To maximize public safety while still maintaining transparency and public access, members of the public can access the meeting by following live at a video link or conference call number that will be provided on the agenda in advance of the meeting.
